Students must complete the Free Application for Federal Student Aid (FAFSA) to be eligible.

 The University has [reciprocity agreements](#) with the states of Wisconsin, North Dakota, South Dakota, and the province of Manitoba, Canada. Resident of any of these states or province may qualify for reciprocity tuition rates, which are lower than nonresident tuition rates and, in some cases, comparable to resident rates. In addition, the Duluth campus participates in the [Midwest Student Exchange Program](#), which allows residents of Illinois, Indiana, Kansas, Missouri, Nebraska, or Ohio to attend at a discounted rate. Costs are estimated for planning purposes. Final housing and fees are estimates and will be determined each summer prior to the new academic year by the Board of Regents.
